## Item No 4: To appraise the Stakeholders regarding recovery from the Corporate Debtors/Assets

The IRP/RP/Liquidator has submitted application before NCLT Court under Section 19(2) and 19(3) of the Insolvency and Bankruptcy Code, 2016 for no cooperation of Directors & Promoters, they have not provided any information/documents of the Corporate Debtor to IRP/RP/Liquidator and as well as not given control of the assets. CA/IA No - 223/2019.

The Landlord of the works is also not co-operating to IRP/RP/Liquidator and application submitted before NCLT Court under section 19(2) and 19(3) of the Insolvency and Bankruptcy Code, 2016 for non co-operation by Landlord of work. CA/IA No. - 698/2019.

The date of hearings was fixed on dated 17.07.2020, 28.08.2020, 07.10.2020, 19.11.2020, 05.01.2021 and 15.02.2021, 12.05.2021, 30.07.2021, 13.09.2021. But the matter could not reached for hearing due to paucity of time. The next date of hearing is fixed on 27.10.2021.

The IRP/RP/Liquidator has sent letters/Emails to Debtors/Trade Receivables to recover outstanding amount as per Provisional Balance Sheet as on 31.03.2017. The Suspended Directors have not provided List of outstanding with address and contact details. # Item No 5: To appraise the stakeholders status of application submitted Under Section 60(5) of IBC, 2016 at Hon'ble NCLT Court

The IRP/RP/Liquidator has submitted application IA/452/2021 before NCLT Court under Section 60(5) of IBC Code, 2016 before the Hon'ble NCLT Court, seeking continuation/extension of liquidation process of Corporate Debtor for a further period of 354 days in terms of provisions of Regulation 47A of IBBI (Liquidation Process) Regulation 2016 by excluding the lockdown period of 354 days from 25.03.2020 till 14.03.2021 due to Covid - 2019 situation in the country. The Application is pending before Hon'ble NCLT Court for adjudication.
